	The most frequently mentioned subject was the excessive volume/speed of traffic (176) followed by poor frequency/reliability/connectivity of the rail and bus services (153) and inadequate/dangerous parking (138). There were 131 suggestions that better management would help both the traffic and parking problems.	1,040			
Theme 4 - The Next Generation	Education, clubs, societies and employment. The most frequently mentioned subject was the lack of facilities/entertainment for young people (80) followed by concerns on secondary education (40).	213
