

CONSULTATION ON THE PRE-SUBMISSION (REGULATION 14) DRAFT HUNGERFORD NEIGHBOURHOOD PLAN

About the Hungerford Neighbourhood Plan

The Neighbourhood Plan is a document that sets out planning and land-use policies relating to Hungerford Parish. It sets out, in development terms, how land should be used within the parish, as well as planning policies to influence development proposals.

The Plan must undergo a rigorous process, including a Strategic Environmental Assessment (SEA), a series of consultations, independent examination, and finally a referendum. If successful, it will form part of the development Plan for West Berkshire and will be used to help determine the outcome of planning applications in Hungerford Parish.

Hungerford Town Council, working with the local community, has been developing the Hungerford Neighbourhood Plan since 2018, and a final draft has just been produced which we are seeking comments on.

The Neighbourhood Plan outlines the vision and objectives for Hungerford Parish, presented in the form of individual policies. The Plan covers the whole parish from 2024 to 2041 and proposes two new housing sites.
